### INTRODUCTION

Cryptid Clan LLC ("we" or "us" or "our") respects the privacy of our users ("user" or "you"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website **cryptidclan.io**, including any other media form, media channel, mobile website, or mobile application related or connected thereto (collectively, the "Site"). Please read this privacy policy carefully. If you do not agree with the terms of this privacy policy, please do not access the Site.

We retain the right to modify this Privacy Statement at any time and for any reason. Any modifications will be communicated to you by amending the "Last Updated" date of this Privacy Policy. Any changes or modifications will take effect immediately after they are posted on the Site, and you waive your right to receive explicit notice of each change or modification.

### **COLLECTION OF YOUR INFORMATION**
